## WAIVER, ASSUMPTION OF RISK, AND AGREEMENT TO HOLD HARMLESS

I understand that attending a dog obedience training class is not without risk to myself, members of my family or guests who may attend, or my dog because some of the dogs to which I/we might be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care.

I hereby waive and release Hidden Valley Obedience Club of North San Diego County, Inc. (hereafter referred to as the Club) from any and all liability of any nature, for injury or damage which I or my dog may suffer, including specifically, but not without limitation, any injury or damage resulting from the action of any dog, and I expressly assume the risk of any such damage or injury while attending any training session or other function of the Club, or while on the training grounds or the surrounding area thereto.

In consideration of and as inducement to the acceptance of my application for membership in this obedience training club, I hereby agree to indemnify and hold harmless the Club, its members and trainers from any and all claims, or claims by any of my family accompanying me to any training session or function of the Club or while on the grounds or the surrounding area thereto, as a result of any action by any dog, including my own.

In addition, I grant the Club, its representatives and members the right to take photographs of me, members of my family or guests who may attend the Club's activities. I authorize the Club to copyright, use and publish the same in print and/or electronically with or without my name for any lawful club purpose, including publicity, illustration, advertising, social networking and web content.

I also understand that it is my personal responsibility to maintain control of any dog in my care and custody while attending any training class or other function of the club.
